#### Multi-purpose approach of transparency in fisheries

Management of fisheries by governments

Compliance of fishing activities

Authenticate seafood in supply chains

Increase public availability and credibility of basic information on a country's fisheries sector to support participatory governance

Provide real-time, technologysupported information on activities of fishing vessels to identify illicit behaviour Increase information to trace fish through the entire supply chain ('from sea to plate') to strengthen consumer confidence



#### Transparency as the bedrock for MCS activities



- Provides context of national fisheries
- Allows dialogue and exchange of information
- Improves data quality
- Builds trust and provides accountability of MCS activities

#### Seychelles and the Fisheries Transparency Initiative (FiTI)



#### Implementing country

Seychelles is committed to implement the FiTI Standard and is currently recognized as a FiTI Candidate country

Seychelles was the first country ever to publish an annual FiTI Report

#### **Host country**

Seychelles is also the host country of the FiTI International Headquarter

#### Prior to FiTI: Significant lack of fisheries transparency

- Seychelles not data deficient, but lacked easy public access to fisheries information
- Spirit of 'reactive transparency' instead of 'proactive transparency' within Seychelles Fishing Authority
- Confidentiality and other legal issues prevented the publication of information/contracts
- Improvements needed on data quality (e.g. financial information)
- Led to misunderstandings (rumours) and underappreciation of fisheries by general public

Seychelies and Taiwan signs new fisheries agreement



The Principal Secretary for Fisheries, Roy Clarisse, told reporters that the changes made to the agreement are to ensure that it is transparent. He said there was a non-disclosure clause in the previous agreement that has now been removed to make it compliant with **Fisheries Transparency Initiative**'s (FiTI) standards.



#### As part of this 2021 FiTI Report, the MOFBE confirmed that:

 no processes and procedures are published for entry into the sea cucumber fishery as no new entrants can be accommodated, given that it is a limited entry fishery and the current status of some species of sea cucumbers are observed to be overfished.

## Transparency in action: Fisheries law enforcement (2/2)



As part of the 2021 FITI reporting process, SFA published on its website, the record of convictions of major offences in the fishing sector as well as a list of foreign vessels apprehended as a result of IUU fishing which occurred during 2020 and 2021.

As detailed in Seychelles' 2020 FiTI Report, several compliance and policy instruments exist and are available online which provide strategic directions guiding fisheries compliance.



The SFA has secured funding to complete the "National Plan of Action (NPOA) for Illegal, Unreported and Unregulated (IUU) fishing', and write it into national policy.



There is no comprehensive report covering national activities and strategies for ensuring compliance of fishing vessels and the post-harvest sector with national legislation for 2021. SFA has not indicated when this will be available although funding has been secured.

#### Next steps



Continuous improvements of transparency through implementation of FiTI National Multi-Stakeholder recommendations



Regular information provision to the general public through new Fisheries Management Information System (FIMS)



Improved collaboration with other FiTI countries in the Western Indian Ocean region, e.g. Madagascar
