# Data Sources and Definitions

Below you can find definitions of some data categories and sources the JAC uses for analysis. As a best practice, always seek to consult more than one data category, and cross-reference information across sources. This is not an exhaustive list of resources and tools and many other sources can be found online depending on the jurisdiction and/or country of interest. This is a resource to help with locating vessel information and other publicly available information that can be used to aid in risk assessments and broader analysis. Please see training presentations also provided for guidance on how to use and interpret sources such as these in risk assessments and analysis.

	The IMCS Network's Combined Regional Authorised Vessels Tool (CRAVT). The CRAVT automatically combines vessel-related data and information from several Regional Fisheries Management Organisations (RFMOs) and Regional Fisheries Bodies (RFBs). The CRAVT can be used to search for specific vessels or browse groups of vessels including by flag, vessel type or RFMO or RFB. The CRAVT identifies where differences exist between RFMO or RFB records for a specific vessel. Users may also search Vessel Contacts (vessel companies and vessel masters) for a specific vessel. #### **Pacific fisheries bodies**

The Forum Fisheries Agency (FFA) is a member body that supports collective and national action for the sustainable use of offshore fisheries resources. The FFA maintains a list of vessels in good standing, a requirement for licensing in an FFA member State.

The Parties to the Nauru Agreement (PNA) control the world's largest tuna purse seine fishery encompassing the exclusive economic zones of member states. PNA Members are Federated States of Micronesia, Kiribati, Marshall Islands, Nauru, Palau, Papua New Guinea, Solomon Islands, Tuvalu and Tokelau. The PNA maintains a list of registered vessels that are in good standing to fish under the PNA vessel day scheme, however this does not indicate that these vessels are licensed to fish in all members' waters. For specifics of vessel licensing, national license information should be requested.

The PNA also maintains a regional licensing scheme for tuna purse seiners - the FSMA Arrangement. Vessels on this list are licensed to operate in the EEZs of all PNA members

#### Compliance History / **Derogatory** Reporting

The TMT Combined IUU Vessel List provides the best available, up-to-date information on all fishing and related vessels that appear on IUU fishing vessel lists published by RFMOs and related organisations. The aim of the site is to improve the effectiveness of the original IUU lists as a tool for a wide variety of stakeholders to better understand and combat illegal fishing and broader fisheries crime.

TMT Combined IUU List

Memorandums of Understanding (MOU) on Port State Controls are regional agreements that aim to ensure vessels comply with international maritime conventions through harmonisation of inspection standards. Most publish lists of vessels detained under their inspection regime for violations of safety or other standards. Some also publish grey and black Paris MOU lists of flags, representing the flag States with the greatest number of vessels detained for violations in a Caribbean MOU given year. Although these regimes do not relate to fisheries violations, they can be a useful resource to identify flag States that could be considered higher
